LPG/Maint(M)-01/750/2014 dtd. 9/7/14 for procurement of "Servo Prime 46" and "Servo Friz F68/57" from IOCL on nomination basis for use in the Inlet Gas Compressor unit of LPG plant.

If one or more links go down during office hours, the bandwidth utilization of the functional links reach upto 100%, thus slowing down the Internet access and affecting the critical services like E-tender, Oilep, Oilweb, Payment Gateway, banking transactions, etc. Therefore the total bandwidth (72 Mbps) needs to be enhanced to avoid such problems in case of link failure. The Internet link from M/s Bharti Limited is the oldest link used by OIL since 2011 and this Internet link is the most stable link and providing quality service to OIL. As such, user deptt obtained in-principle approval from Management to augment the existing 24 Mbps bandwidth from M/s Bharti Airtel to 48 Mbps to have a total bandwidth of 96 Mbps, through a nomination order. Accordingly, PO no. 7512112 was placed on nomination basis on M/s Bharti Airtel with a "One time upgradation Charge" only and free-of-cost recurring charges for upgradation of Internet bandwidth, with approval from competent authority.

LTD., Mumbai	N/A	N/A	The crude being produced from the well Mechaki-5 (MKB-1) since 04.03.2017 @ around 100 KLPD contains more than 16% wax and has a Pour Point of 42°C. As such, its transportation through bowsers (loading and unloading) is creating a lot of operational difficulty. Accordingly, R&D Department had taken up the Flow Assurance study for Mechaki-5 crude on priority basis, and now have identified a new Liquid Flow Improver (LFI) chemical formulation named "CRISTOL SGT 07" which reduces the Pour Point of Mechaki-5 crude. This new LFI chemical has been specially developed last month by a specialty OFC manufacturer M/s Krishna Antioxidants Pvt Limited, Mumbai on request and under the guidance of R&D Department; and it is the only FI formulation [out of the 15 existing and newly developed Regular (solid) or Liquid Flow Improver products from different vendors that have been tested so far] that has been found effective on this crude.  View above, in-principle approval from Management was obtained by user department to procure 36 MT of this LFI product "CRISTOL SGT 07" on Nomination basis from M/s Krishna Antioxidants Pvt Limited, Mumbai for conducting a trial of three months period.  Accordingly, PO NO. 7512151 was placed on Nomination basis on M/s Krishna Antioxidants Pvt Limited, Mumbai with the approval of competent authority for procurement of 36 MT of LFI.

All works/Purchase/Consultancy and other contracts, in progress, as per prescribed monetary limit and approved under Srl. No. 34 I(A) of DOP have been reported in this QPR.
