M/s SGRPPL also shared two quotations from parties which conduct on-site testing.</p> <p>M/s Vintage Power Solution quoted INR 16,70,000.00, while M/s Ascent PowerTech quoted INR 14,68,500.00. All the generators at Chandgarh, MP unanimously decided to carry out the Onsite Testing of Energy Meters and Metering Equipment through M/s Ascent PowerTech, as the quoted price of M/s Ascent PowerTech was found to be reasonable.</p> <p>It is important to note that OIL is one of the generators at Chandgarh site and is connected to the state grid through a PSS (Pooling Sub Station) with other generators. As all the generators are connected through a common PSS, the expenses incurred for the requisite Onsite Testing of Energy Meters and Metering Equipment shall be on a sharing basis.</p> <p>Accordingly, OIL received a quotation of INR 3,72,020.00, which is 25.33% share of the total cost</p>

								<p>of INR 14,68,500.00 from M/s Ascent PowerTech against their installed capacity of 38 MW at Chandgarh, MP.</p> <p>The price offered to other generators in the wind farm is on similar terms for the services. Therefore, the reasonableness of the price is felt to be in order.</p> <p>Since the Testing of Energy Meters and Metering Equipment is a statutory requirement and considering the limitation of time, its felt prudent to award contract to M/s Ascent PowerTech, for Onsite Testing of Energy Meters and Metering Equipment, for OIL's 38 MW Wind Energy Power Plant (WEPP).</p>

Ltd., Ghaziabad for Hiring of Manpower Services on Call Out Basis for a period of Four (04) years against Part-A of Tender No. CJI9198P19 for Rajasthan Project at a total estimated contract value of INR 7,24,89,600.00 exclusive of GST. The contract is valid up to 26.05.2023. As on date 18 nos. of contractual manpower have been employed through this contract.</p> <p>Meanwhile, Contract no. 6116974 was awarded to M/s ANI Integrated Services Ltd. from FHQ, Duliajan for Hiring Services of Qualified and Experienced Professionals to be engaged temporarily at Executive Cadre on Call Out Basis in Operational Area(s) or Installation(s) of Oil India Limited within India. As the contract caters to the manpower requirement of all locations of OIL in India, HR&A department of RF vide email dated 26.12.2022 provided the tentative projected requirement of contractual manpower at RF for current and future operations. The total manpower requested was 43 nos. covering all departments of</p>

								<p>RF.</p> <p>However, the manpower allocated under contract no. 6116974 was not sufficient to cater to the requirement projected by RF as follows:</p> <p>i) The quantity allocated to RF was much lesser than the current and projected requirement of RF for its operations.</p> <p>ii) The contract does not have provision for allocation of manpower of certain departments of RF like F&A.</p> <p>Deployment of manpower at RF against the increased quantity from ANI will only be possible after completion of procedural formalities. Accordingly, it is assumed that deployment through ANI will be delayed and placement of manpower at RF cannot be done before expiry of Priserve contract on 26/05/2023.</p> <p>It is prudent to mention here that, to ensure continuity of operations/services through contractual engineers /officers under contract no. 6113058 till suitable manpower is placed either by direct contractual recruitment or through contract no. 6116974. It was decided to award a separate contract on nomination basis for Hiring of Manpower Services on call out basis for Rajasthan Field to M/s. Priserve Infrastructure Pvt. Ltd., Ghaziabad for a period of 3 months with a provision of early termination.</p>
