								<p>It is also pertinent to mention here that, as per clause no.- 2. Definition (s) of the MPERC (Forecasting, Scheduling and Deviation Settlement and related matters of solar and wind generating stations) Regulations, 2018 (copy attached), there can be only one qualified QCA for a single pooling sub-station. Hence, in the year 2018, Majority of the generators appointed M/s Manikaran Analytics Limited as their common QCA for the 150 MW Wind Farm at Chandgarh.</p> <p>Accordingly, Oil India Limited appointed M/s. Manikaran Analytics Limited as the QCA of 38 MW WEPP vide Contract No. 6111908 dt. 17.07.2018 (copy attached) on nomination basis for a period of (03) Three years till 31.07.2021. Thereafter, a new QCA contract No. 6115944 dt. 30.07.2021 (copy attached) was awarded to M/s MAL on nomination basis for 20 Months. This contract is going to be expired soon on 31.03.2023.</p> <p>It is worthwhile to mention here that M/s CLP Wind Farm India Private Limited is the majority stake holder in the Wind farm with a stake of 92 MW out of 150MW Wind Farm capacity. As our contract with M/s Manikaran Analytics Limited (Present QCA of the Wind Farm) is valid up to 31.03.2023, we have communicated with the Majority Stakeholder M/s CLP Wind Farm India Private Limited regarding appointment of QCA in the Wind Farm. M/s CLP Wind Farm India Private Limited has informed us that they have appointed M/s Manikaran Analytics Limited as the new QCA for the period from 01.04.2023 to 31.03.2025 (E-mail communication attached) with a provision of extending it to till 31.03.2026.</p>

								<p>In view of this, OIL has no option left but to go with the majority stake holder in appointing the new QCA. It is felt prudent to engage the existing QCA M/s Manikaran Analytics Limited as the new QCA for OIL's 38 MW Wind Energy Plant at Chandgarh, MP with the same terms and conditions of the existing Contract No. 6115944. It is also clear that, as per the regulation, OIL cannot appoint a fresh F&S and DSM service provider by prevailing standard tendering process as there can be only one QCA per pooling station as per the above-mentioned regulations.</p>
