1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

The buyer organization is an institution eligible for concessional rates of GST as notified by the Government of India. The goods for which bids have been invited fall under classification of GST concession and the conditions for eligibility of concession are met by the institution. A certificate to this effect will be issued by Buyer to the Seller after award of the Contract. Sellers are requested to submit their bids after accounting for the Concessional rate of GST.

3. **Generic**

Wherever Essentiality Certificate is applicable (PEL/ML), successful bidder should provide Proforma Invoice for processing for EC application and material should be dispatched after receiving of EC from DGH. In view of the same, an ATC may be incorporated in GeM, viz, "BIDDER/OEM must provide Proforma Invoice for processing for EC application within

a) The offer should be submitted in a tabular form specifying the specification against NIT specifications for each point. Offer in any other form will not be acceptable.

b) The offer shall be accompanied with Product catalogue / Literature and Drawing showing general arrangement and dimensional details of the offered model.

c) Guarantee / Warranty Certificate (for each instrument) from the OEM, valid at least for a period of 18 months from the date of dispatch or 12 months from the date of receipt at destination, whichever is earlier should be provided along with the materials. Bidder has to confirm.

d) Operation/maintenance manual for each instrument should be provided along with the materials. Bidder to confirm.

e) Materials will not be accepted if any manufacturing defects / transit damages observed after receipt of the materials. Bidder to replace/rectify the same within a short period of time for acceptance.

f) Bidder needs to submit hazardous area certificate at the time of bid submission, failing which the bid will be immediately rejected.

g) Cost of accessories of the item should be included in quoted item.

h) Bidders are requested to submit the compliance sheet (Annexure-I) along with their offer. Bids without the compliance sheet (Annexure-I) will be treated as incomplete bid.

i) Bidders are to take a careful note of all the tender terms and conditions and attachments enclosed in the tender document while bidding. It will be the bidder's responsibility to carefully go through the contents of the tender and bid accordingly. Further, it is the bidder's responsibility to upload relevant documents in the concerned appropriate tabs / fields of the GeM portal while participating in the bid.
