1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

a) Duration of the service contract may be extended up to 1 year beyond the initial contract duration (subject to satisfactory performance and at the sole discretion of the company) at the same rates, terms & conditions.

b) Bidder should not upload any price in the technical bid. Any mention of such facts will result in outright rejection of the bid.

d) The monthly wages of the personnel have been defined by OIL as mentioned above as per Minimum Wage rate effective from 01.10.2023 vide order dated 26.09.2023. The bidders only must quote for **handling charges** (excluding GST) and compute the **Total Contract Cost** which is to be entered in the "OFFERED PRICE" field while creating response against the tender in GeM portal.

8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
