Brief Description of the Approval Granted by Competent Authority

c. **(d) ACCEPTANCE OF OFFER AND SAMPLE SUBMISSION CLAUSE:** The whole tendered quantity will be procured from seller(s) who have satisfactorily executed development order (i.e., including satisfactory inspection and Field Trial Testing) for Hexamine in the past in OIL/ONGCL. Seller(s) to provide samples of their offered product in triplicate (i.e., 3 samples each of ½ Kg) free of cost for laboratory evaluation before bulk supply, in the event of placement of order. These samples will be tested in OIL’s laboratory as per tender specification and the acceptance/rejection of the sample will be decided on the basis of OIL’s laboratory test report only. **(IV)** Bidders must quote their prices on F.O.R. Destination basis (including cost of loading as well as unloading).

**(V) APPLICABILITY OF BANNING POLICY OF OIL INDIA LIMITED:** Revised Banning Policy dated 17.03.2023 as uploaded in OIL's website and revised guidelines of banning/debarment vide OM no. F.1/20/2018-PPD dated 02.11.2021 issued by Department of Expenditure, Ministry of Finance, Govt of India will be applicable against the tender (and order in case of award) to deal with any agency (bidder/contractor/supplier/vendor/service provider) who commits deception, default, fraud or indulged in other misconduct of whatsoever nature in the tendering process and/or order execution processes.
