OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

In addition to the Golden parameters as specified in the bid, the Insulation Tester shall have following specification and features:

1. Test Voltages: 250V, 500V, 1000V, 2500V, 5000V via selector switch
2. Equipment must be Mains and Battery operated.
3. The equipment must provide with facility of locking the test leads so that they don't get removed accidentally while operation.
4. The test leads must comply with IEC61010-31: 2008.
5. The equipment must be built in a rugged case and have facility to perform Breakdown and Burn Mode Present.
6. Equipment must have valid Guard Terminal.
7. Battery Charging Time: Max 3 Hrs

Special Terms & Conditions:

1. The instrument must be new, unused and free from any manufacturing defects and physical damage. The meter display, software and all the literatures of the meter must be in English language only.
2. Offer with catalogue/leaflet/technical literature should be forwarded for technical scrutiny.
3. Make & Model of offered item should be specifically mentioned. Incomplete offer shall be liable for rejection.
4. Material shall be procured either from OEM or authorized dealer only. Authorized valid dealership certificate shall be furnished along with the offer failing which offer shall not be considered for evaluation.
5. All supplied materials should be guaranteed for minimum 1 year from the date of acceptance by user. Warranty/guarantee cards should be duly signed and stamped by the supplier and should be provided with the materials.
6. The maximum allowable delivery period after receipt of Order shall be 06 (six) months.

6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export

experience.

11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
